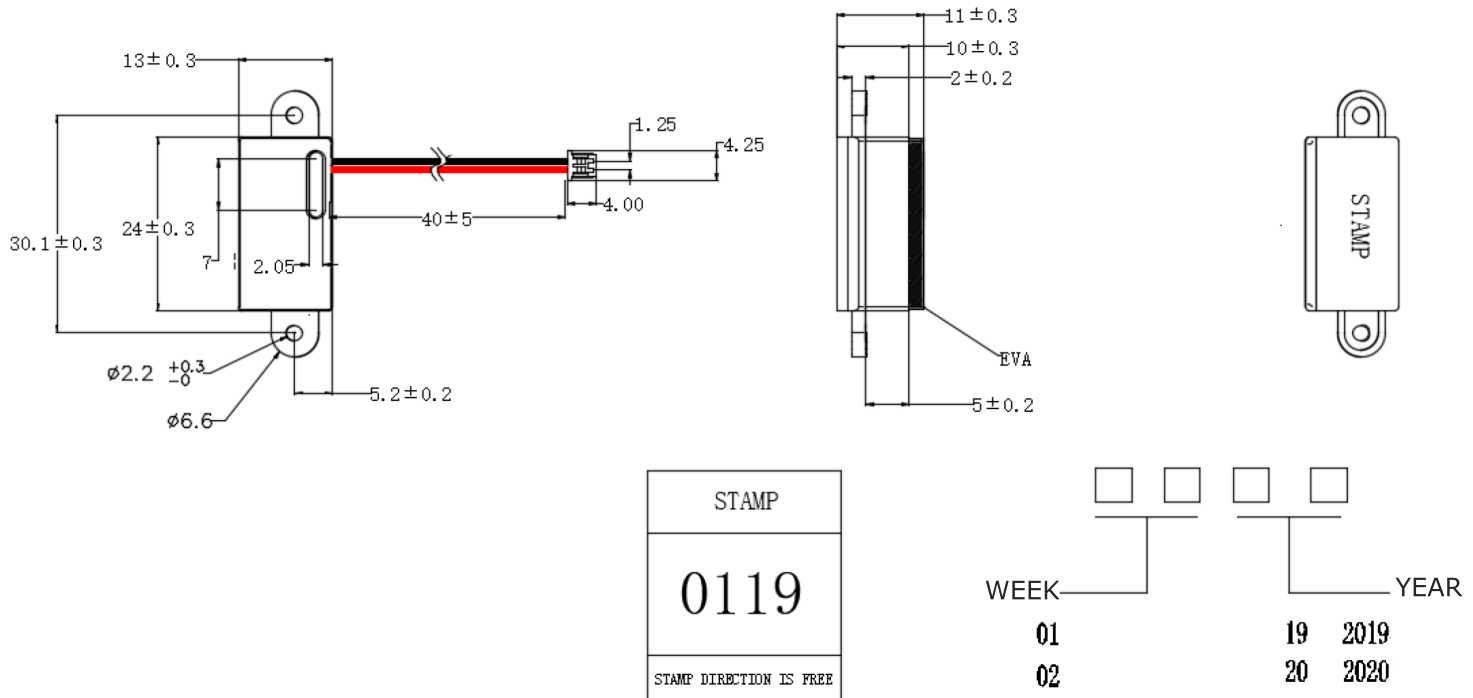

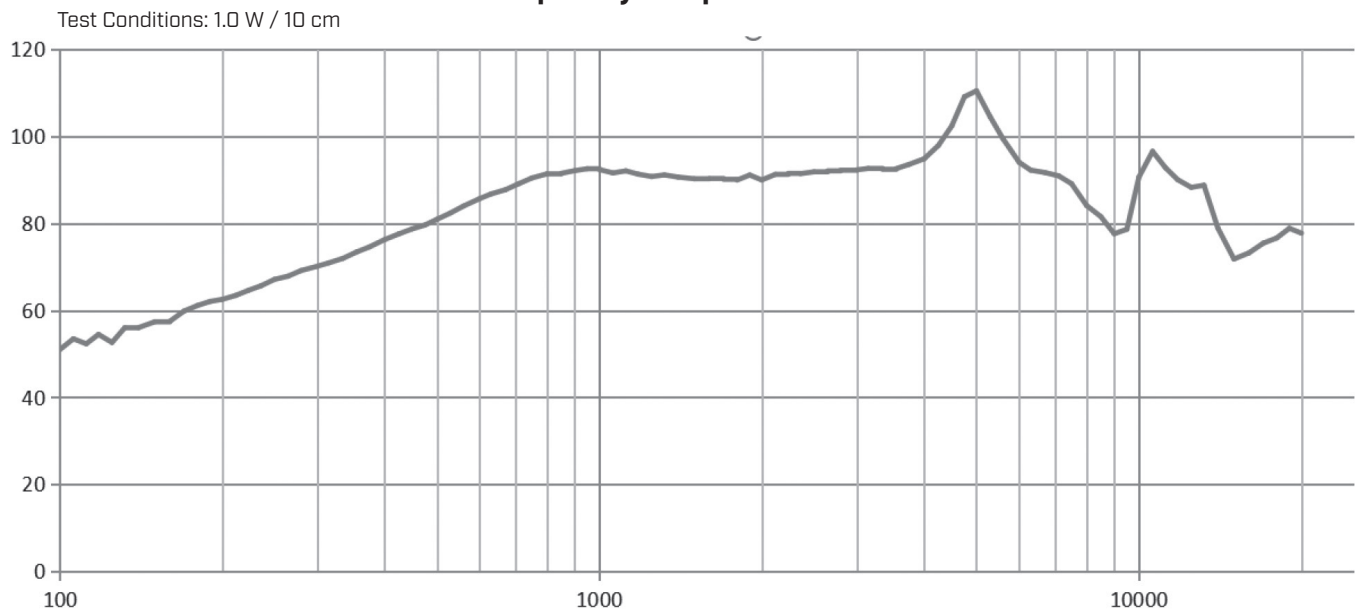

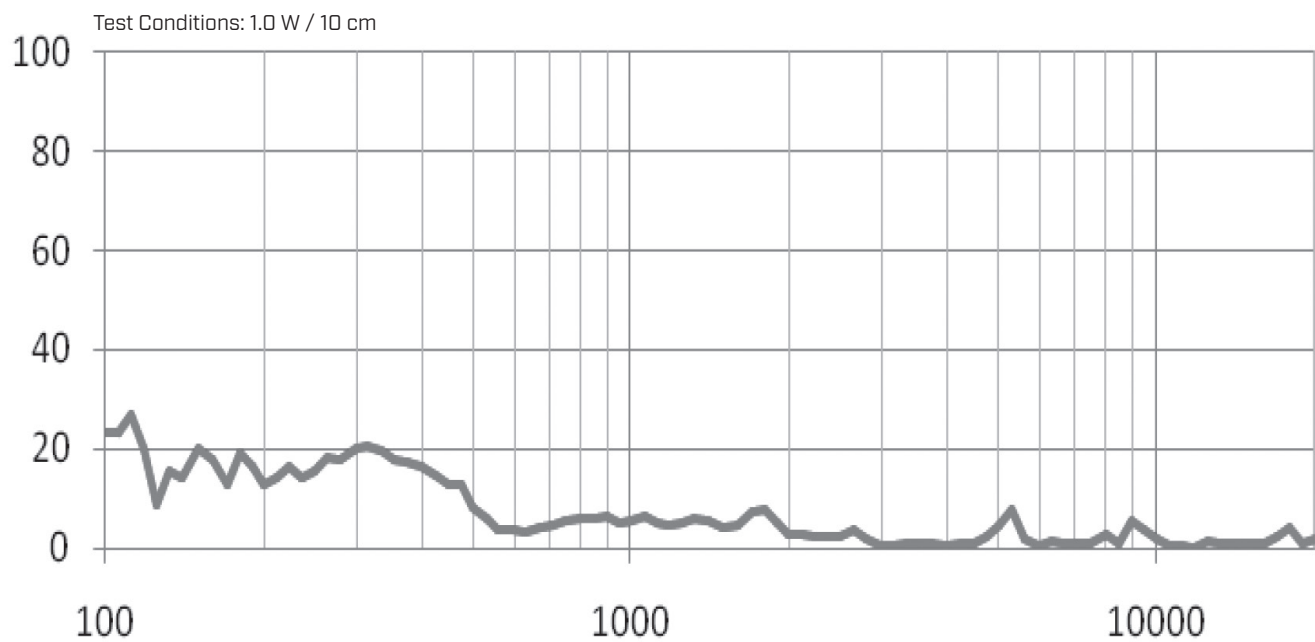


RESPONSE CURVES

Frequency Response Curve



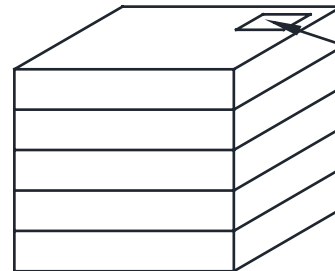
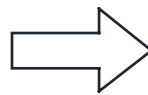
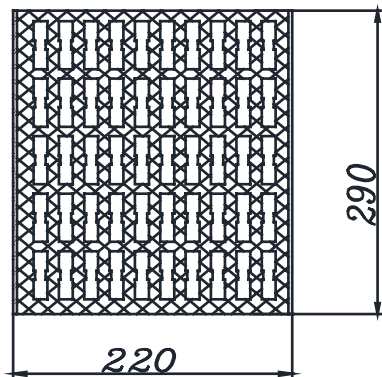
Total Harmonic Distortion Curve



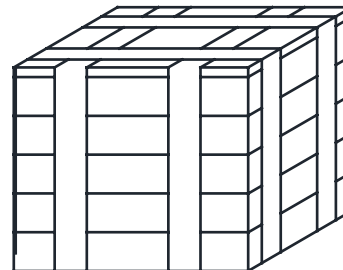

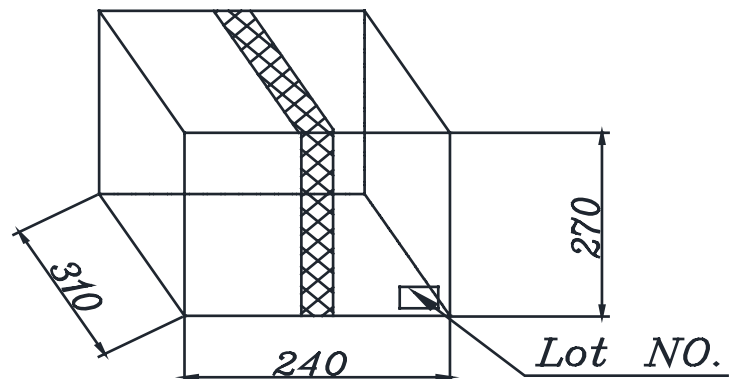
