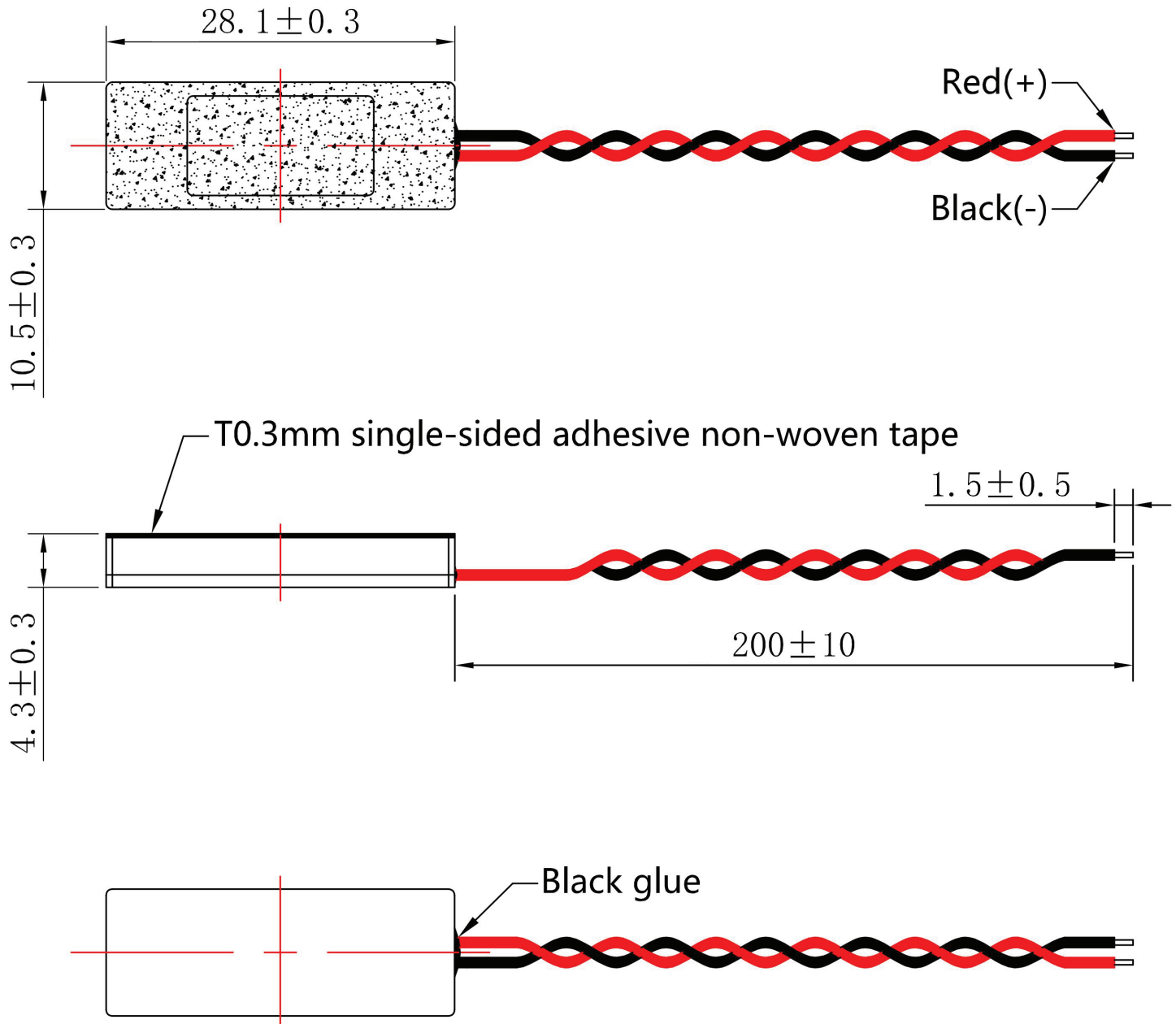

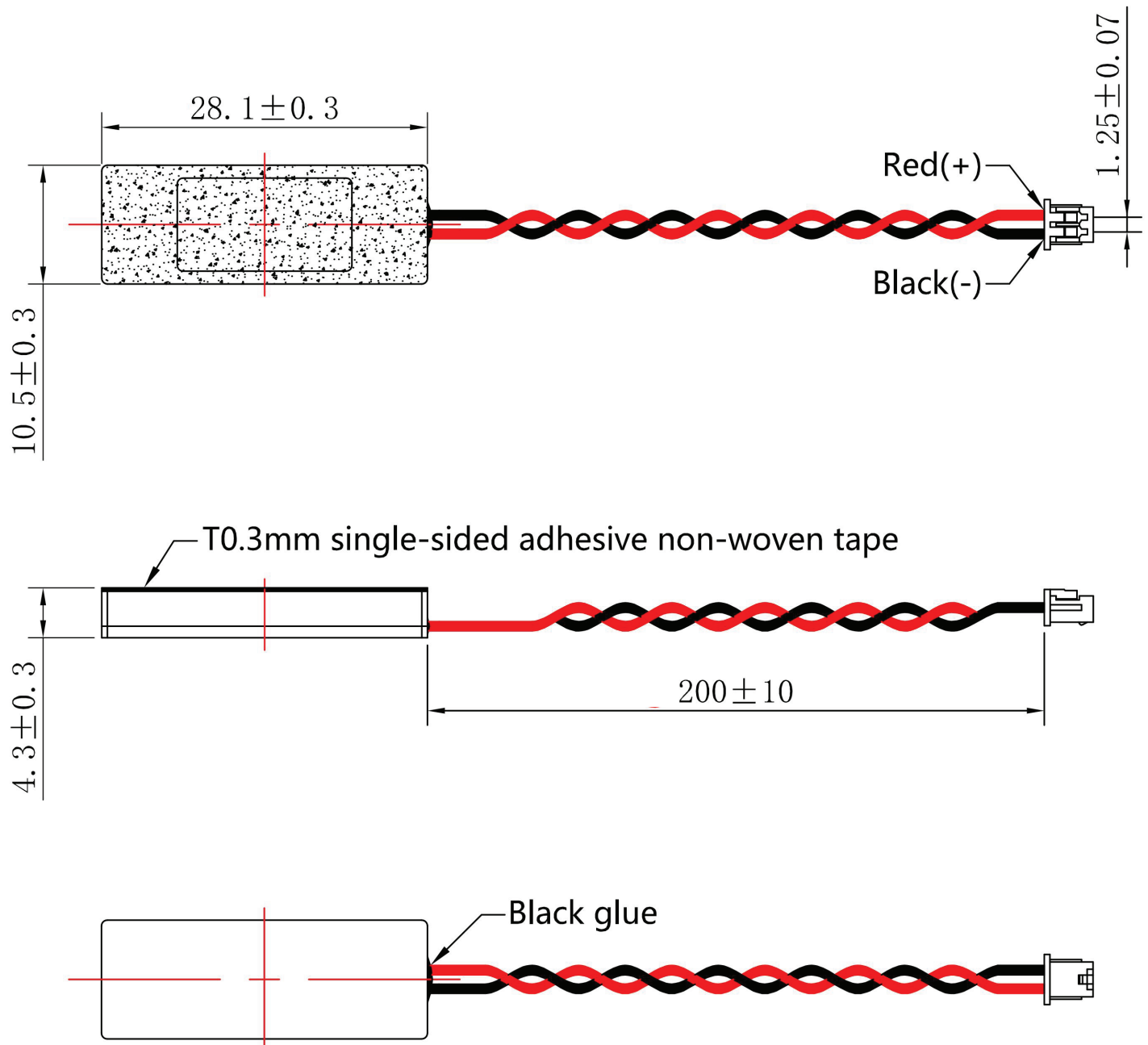

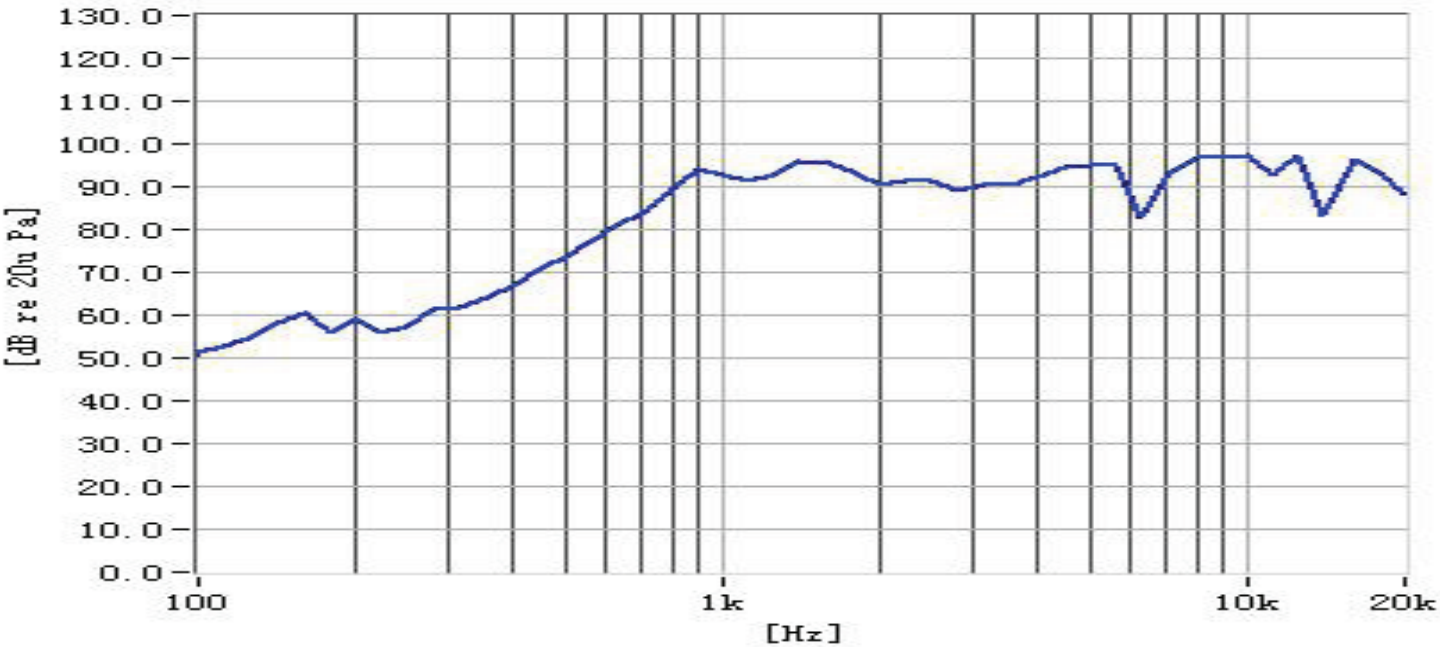

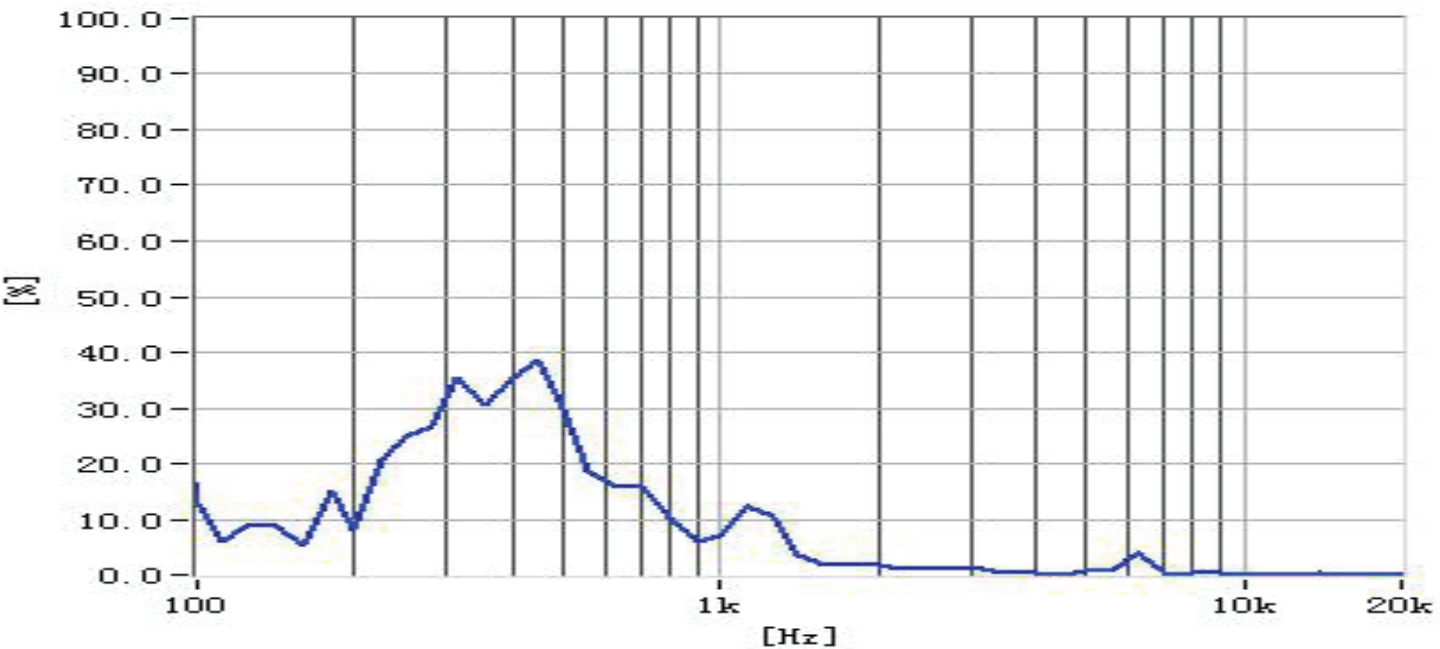


RESPONSE CURVES
