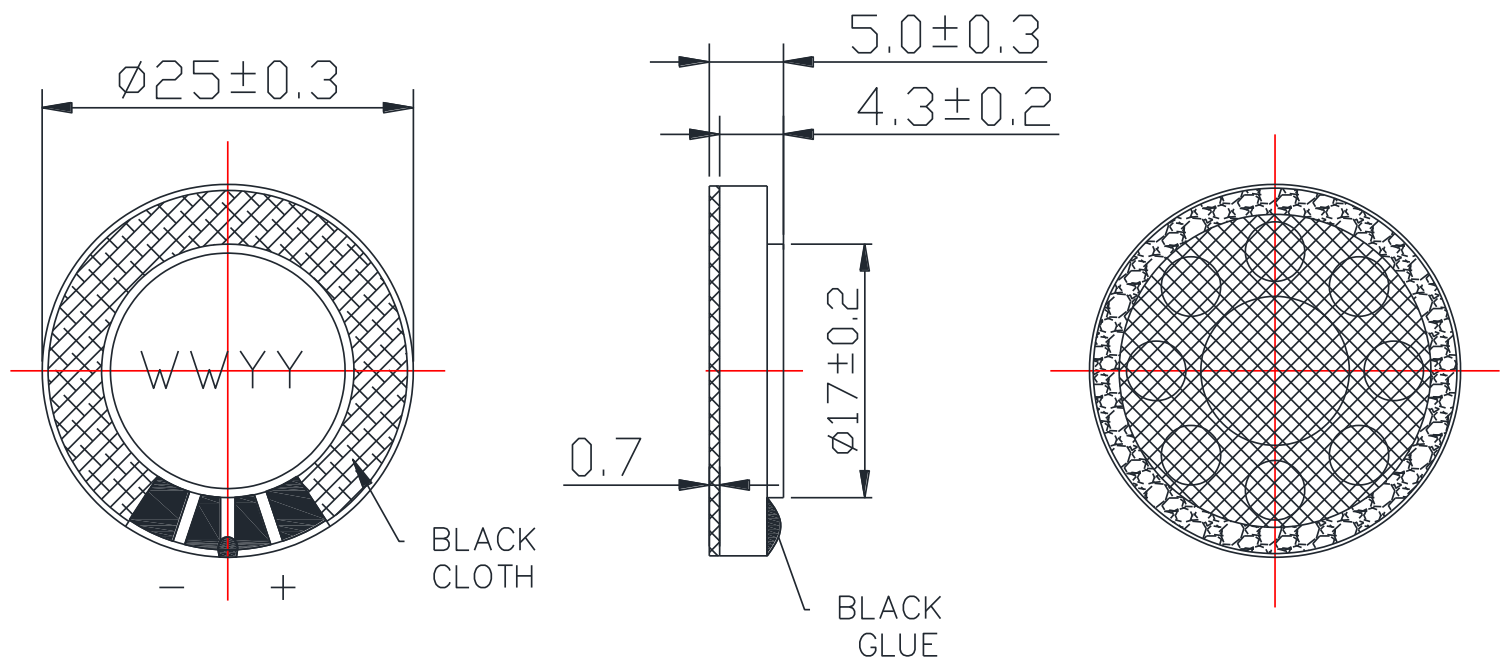

MECHANICAL DRAWING (SOLDER PADS)

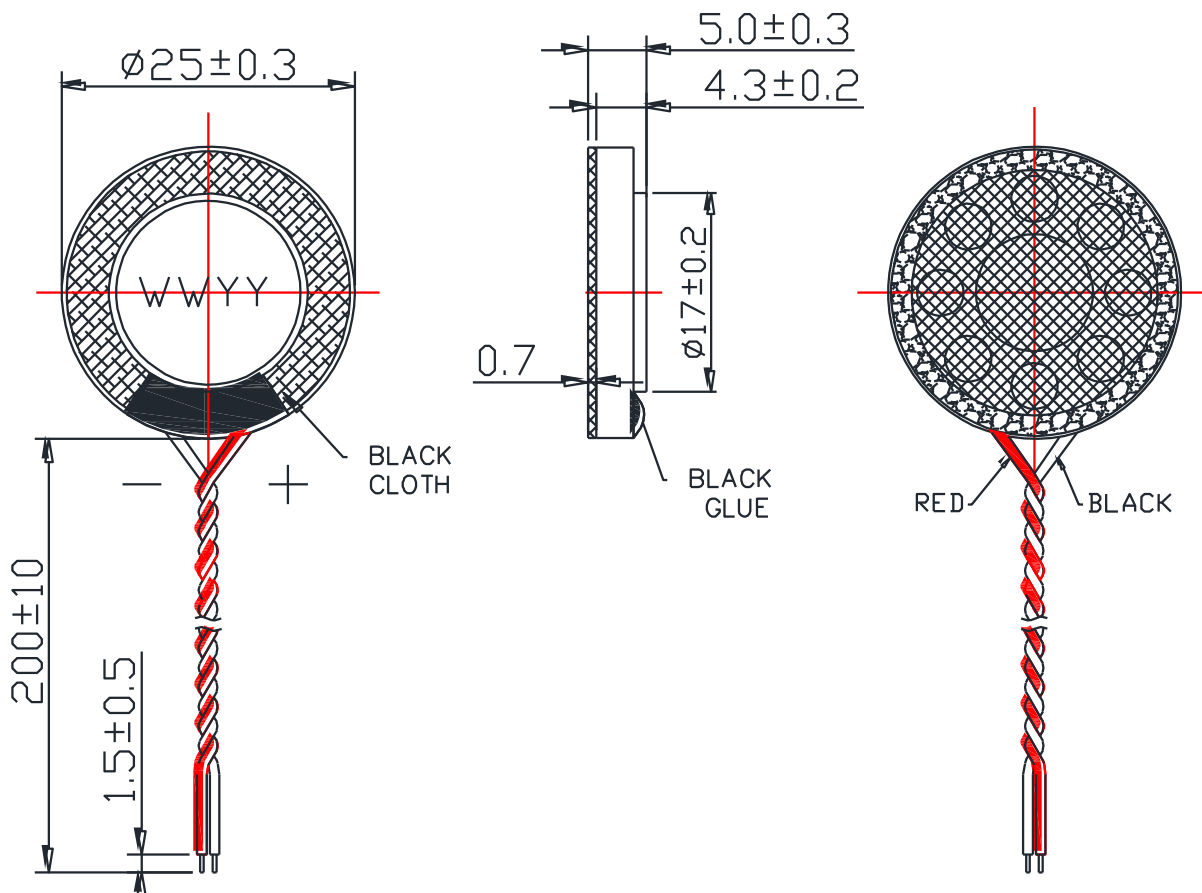

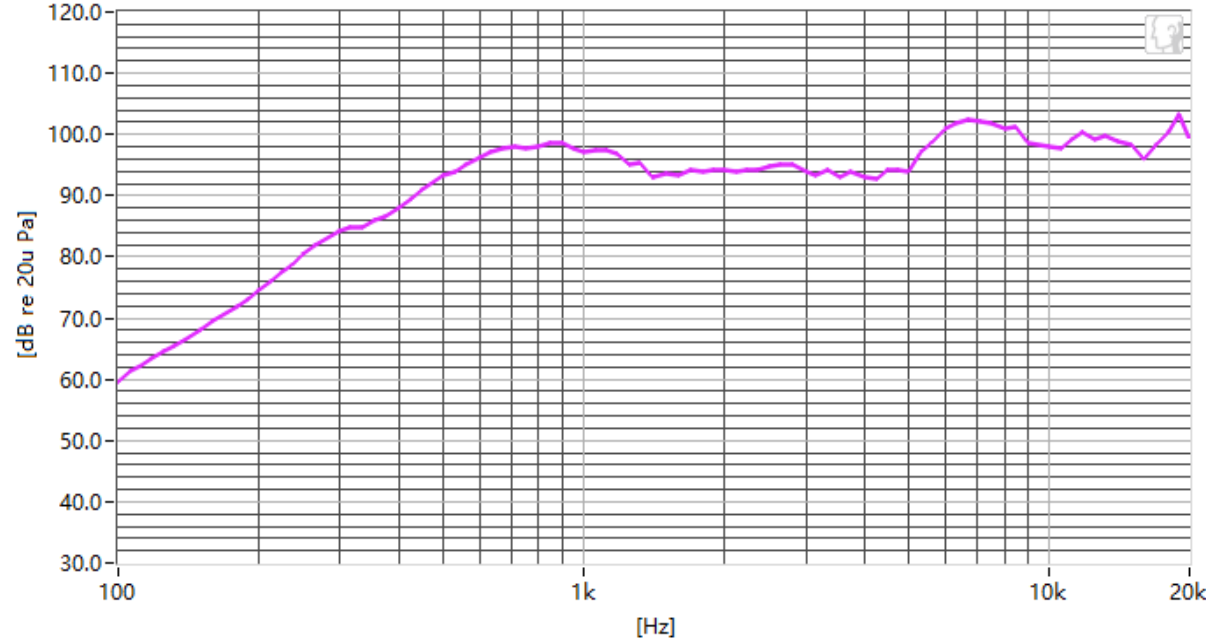

RESPONSE CURVES

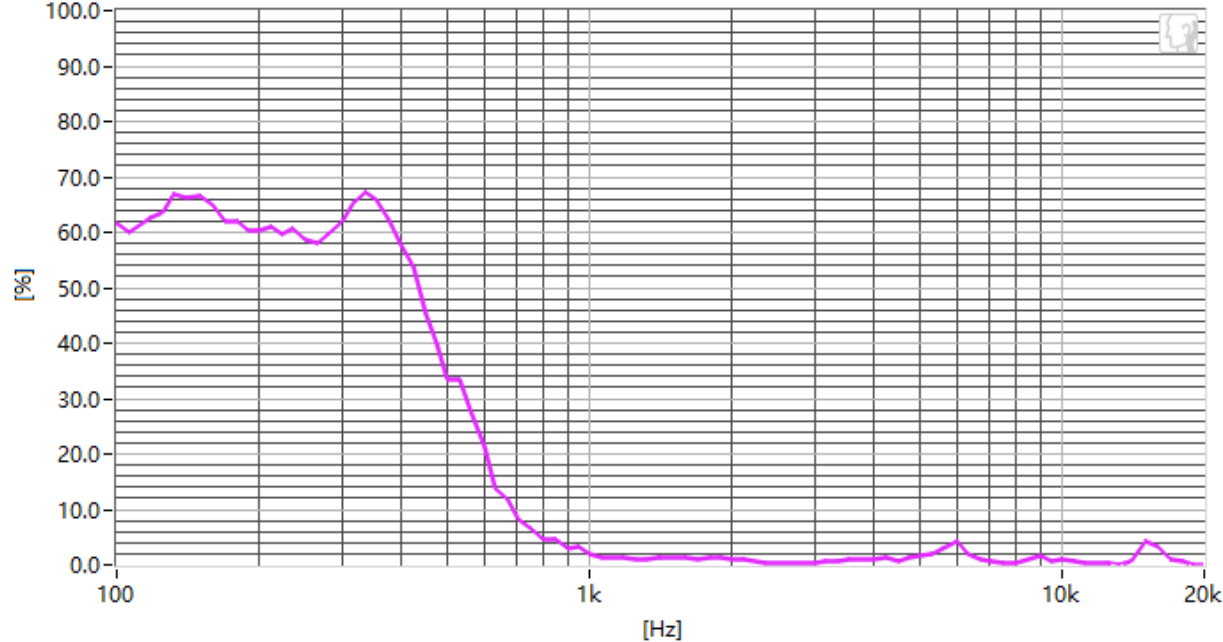
Frequency Response Curve
