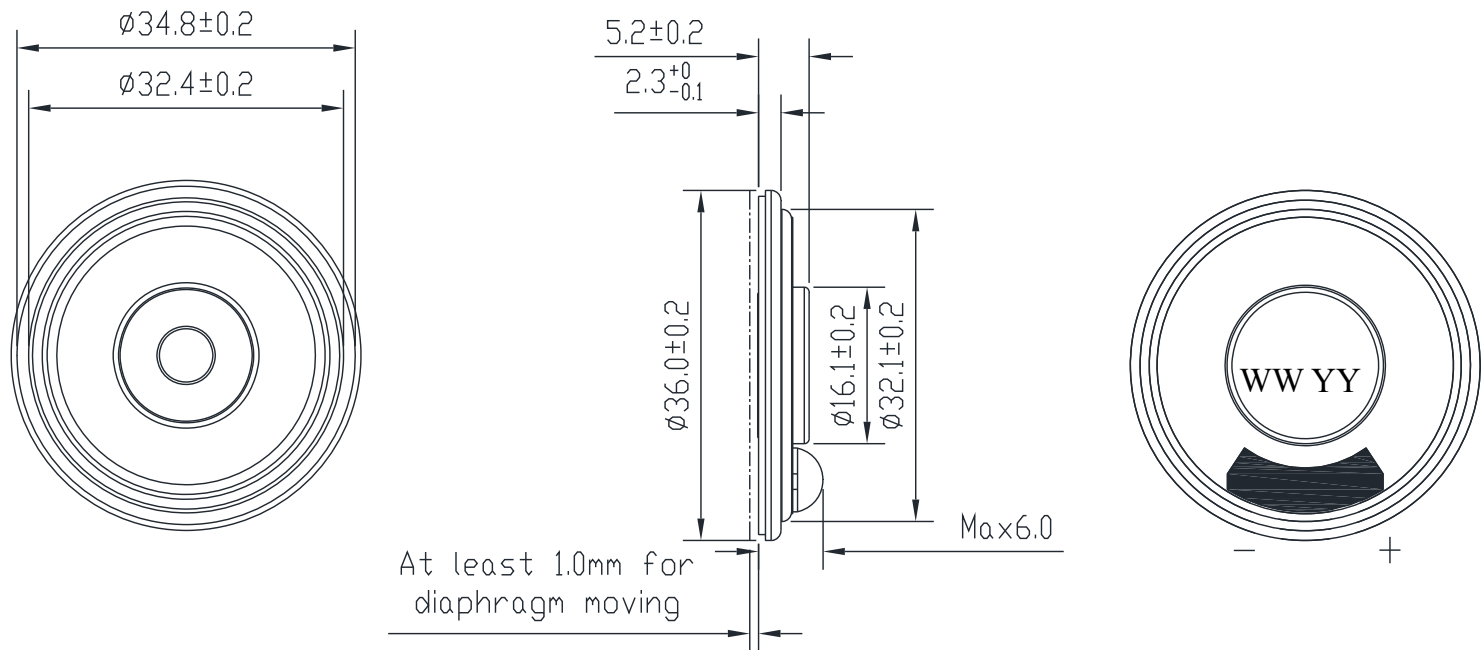

MECHANICAL DRAWING (SOLDER PADS)

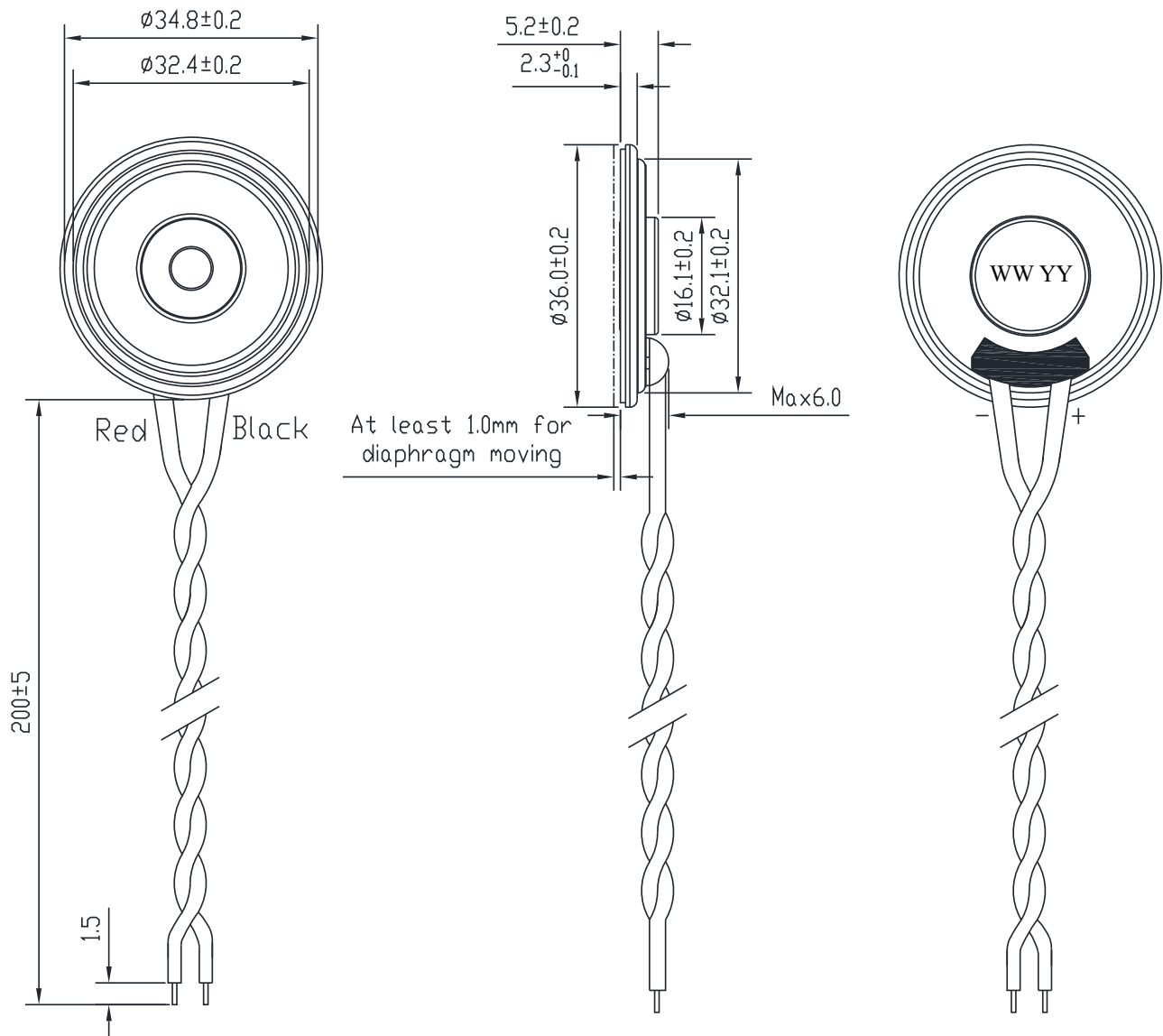

MECHANICAL DRAWING (WIRE LEADS)

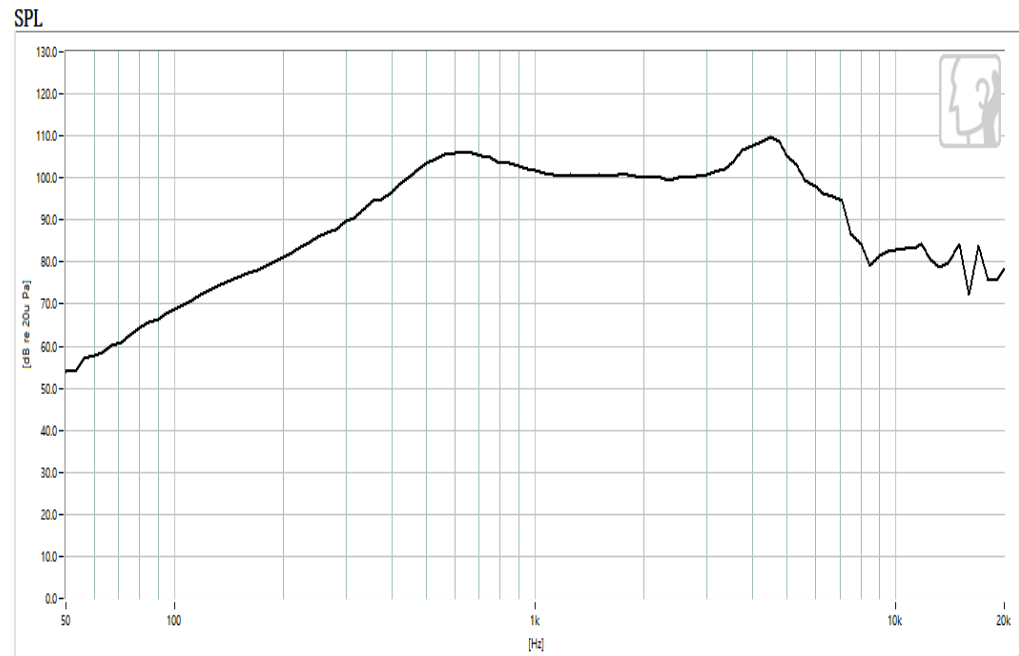

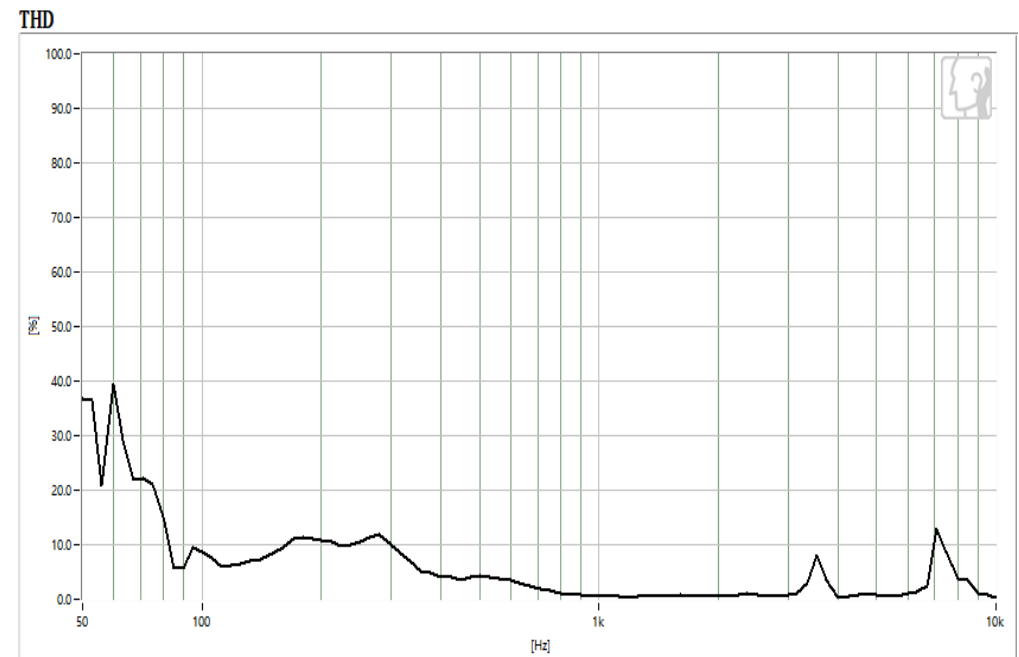


RESPONSE CURVES
